#### DIRECTIONS FOR USE

GROW-GRAIN™ is recommended for use on crops during plant growth periods that require relatively high levels of macro and micronutrients, GROW-GRAIN™ is a fully water soluble, effective, readily available source of the nutrients shown in the guaranteed analysis for soil and foliar applications.

GROW-GRAIN™ will be influenced by differences in crop varieties, soil and environmental conditions and should be applied under conditions of optimum plant growth. Optimum conditions are defined as adequate humidity, moderate temperatures and adequate soil moisture.
