DIRECTIONS FOR USE

Power P is recommended for use on all crops during plant growth periods that require relatively high levels of nitrogen, phosphate and zinc. Power P is fully water soluble and provides readily available nutrients as shown in the guaranteed analysis for soil applications. Power P will be influenced by differences in varieties, soil, and environmental conditions and should be applied under conditions of optimum plant growth. Optimum conditions are defined as adequate humidity, moderate temperatures, and adequate soil moisture.

- Wear suitable protective clothing when applying with other products.
- For optimum results Power P should be used in a plant nutrition program. Recommendations should be based on soil and leaf analyses.
- Consult with your distributor, crop adviser or manufacturer should crop specific programs, or application rates be required.
- Do not apply as a foliar fertilizer.
- Where overhead irrigation systems are in use, avoid scheduling irrigation directly after application.

CAUTION

Do NOT mix or apply in combination with calcium containing products, amine herbicides, copper containing fungicides, sulfates, phosphates, phosphonates, highly alkaline material such as lime sulfur, MCPA or highly alkaline boron products.
